M Gross Quantity: Quantities are reported in thousand cubic feet (MCF) for natural gas, or barrels (Bbls) for crude oil, condensate, and plant products.

N Gross Price

O Gross Value

P Gross Deductions: The dollar value associated with the corresponding deduct code listed in item I.

Q Net Value: Total property value after post-production costs and production taxes.

R Owner Volume: Your share of the property's gross quantity.

S Owner Gross Value: Your share of the property's gross value.
